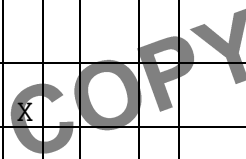

These new or purchased gifts include toys, Easter baskets, backpacks with school supplies and occasionally other new gifts for the children, such as diapers, new books and new baby clothing.

M.C.C. provided gifts to 13 bereaved children all year, including recognizing each of their birthdays. M.C.C. reached nearly 60 U.S. Military Commands and/or Bases this past year with gifts in California, Texas, Hawaii, Saipan and Guam.

M.C.C. hosted a holiday family-day event for the entire Marine Corps Recruiting Station in Orange County, ensuring they had a complete holiday meal, were entertained by a live band and each child received a toy. M.C.C. was on hand at 3 family-day summer events to pass out gift bags to a few hundred Army and Marine Corps children.

Also, M.C.C. received approval to begin supporting the Marines Corps Wounded Warrior program in Southern California with gifts for the children. Lastly, at year end

M.C.C. was well into planning another base-wide baby shower at JFTB Los Alamitos supporting all joint forces set to occur on August 9, 2014. These good works were accomplished by an all-volunteer team of dedicated individuals who care passionately about supporting our U.S. Armed Forces, their mission, their spouses, and above all, their military children.
