In 2021, M.C.C. utilizing its vast military/government network, answered the call to assist 17 VIP Afghans, including women and children, to be evacuated during the fall of Kabul Afghanistan, in August 2021. This large family unit was one of the foremost in assisting the United States secure its national security/military objectives the past two decades.

Next, receiving these Afghans physically in September from the U.S. Military, in Southern California, M.C.C. ensured they had clothing, food, urgent medical care (for children and a young man with active cancer), legal and multiple other life necessities in order to survive while they waited for Social Services and their assigned other agencies to step forward to assist us.

M.C.C. worked in close coordination with a CA State Senator, a CA Member of Congress and Chapman University to provide as much support as possible to other Afghan refugees in the area. M.C.C. additionally provided gift support to multiple other large Afghan families in Southern California.

Finally, M.C.C.'s CEO Cherie spent over 3 months daily teleconferencing with U.S. Military and Civilian Senior leadership, sharing what was occurring day to day in the resettlement activities, in order to assist key stakeholders with learning and best practices being developed nationwide.

Additionally, M.C.C. hosted a multi-service branch baby shower aboard the JFTB Los Alamitos for the 9th year. Further, M.C.C. provided major support to military holiday family events, such as the Los Angeles Air Force/Space Force Base.
