In total, nearly 139,000 gifts of appreciation have been distributed to U.S. Military and Bereaved Families - Mission Accomplished!

Lastly, in an extraordinary effort, MCC's all-volunteer team assisted to rescue 17 individuals, including women and children, during the fall of Afghanistan from Kabul Airport and resettle them successfully into Orange County, California. Specifically, this was a VIP family to the United States government, and our team members dropped everything to answer this call, ensuring their safe and successful resettlement into our nation.

During this fiscal year, our team not only continued support for our Afghan foreign national guests, but also, supported them in 2 unique ways. For one of the Afghan pregnant couples, MCC arranged to bring in other non-profits to cover their baby shower gifts. Second, when another of the Afghan pregnant couples lost their baby, MCC contributed towards the burial/funeral costs. Also, MCC arranged through another nonprofit to cover the entire cost of the unexpected burial/funeral costs.

Next, during this fiscal year our CEO and CFO flew to Virginia to attend the funeral at Quantico of a retired U.S. Marine who was employed at the Pentagon when he died young and suddenly from cancer. MCC was present to provide comfort to the 3 young adult children that lost their father.

M.C.C. remains All-Volunteer and across 13 years still has NO paid staff members. Our volunteers have shown up for our nation for the past 13 years out of patriotism and care for our U.S. Armed Forces. Military children across multiple branches of the U.S. Armed Forces were repeatedly reminded that American's care about their sacrifices for their parent(s) to serve our nation.
