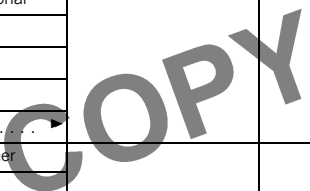

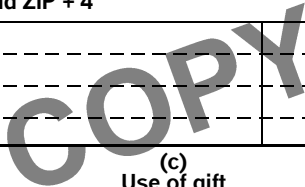

M.C.C. receives new gifts and monetary donations for American Service member's children, ages 0 - 18 years old, to acknowledge their repeated sacrifices. These new or purchased gifts include toys, Easter baskets, backpacks with school supplies and occasionally other new gifts for the children, such as diapers, new books and new baby clothing.

During M.C.C.'s 5th fiscal year, our all-volunteer team collected & distributed 326 Easter Baskets, 2,926 books, 2,512 toys, 4,464 school supplies, 411 baby shower gift items, nearly 500 children's clothing items and over 13,000 dollar toys to American Servicemember's families. M.C.C. provided gifts year-round, (including birthdays,) to 11 children who have lost a parent in service to our nation. M.C.C. hosted 5 large-scale events on behalf of the U.S. Armed Forces, including a base-wide baby shower at JFTB Los Alamitos, a holiday event for an Aviation/ Helicopter command about to deploy for over a year to Afghanistan & a holiday event for a large U.S. Marine Corps command. Also, M.C.C. supported multiple other military family events, like summer barbeques & Halloween. Over the past 5 years of operation, M.C.C. has now distributed 1,376 Easter Baskets, 785 backpacks filled with school supplies, over 33,300 toys/ gifts, 7,768 books and nearly 20,000 baby items. In total, over 80,000 gifts of appreciation have been distributed. To date, there are no paid staff members, M.C.C. remains an all-volunteer organization. Military children across multiple branches of the Armed Forces were repeatedly reminded that American's care about their sacrifices for their parent(s) to serve our nation. MCC received multiple awards and recognitions from the military this year for our support acknowledging their military children.
