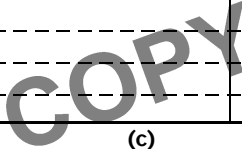

M.C.C. receives new gifts and monetary donations for American Service member's children, ages 0 - 18 years old, to acknowledge their repeated sacrifices. These new or purchased gifts include toys, Easter baskets, backpacks with school supplies and occasionally other new gifts for the children, such as diapers, new books and new baby clothing.

M.C.C. provided Easter baskets, backpacks, holiday gifts and birthdays presents to 11 children who have lost a parent in service to our nation. M.C.C. hosted 3 large-scale events on behalf of the U.S. Armed Forces, including a base-wide baby shower at the JFTB Los Alamitos for the 4th consecutive year, a holiday event for an Army Aviation command & a holiday event for a large U.S. Marine Corps command. Also, M.C.C. supported additional military family events. Over 6 years of operation, M.C.C. has now distributed 1,387 Easter Baskets, 836 backpacks filled with school supplies, nearly 35,700 toys/ gifts, 9,755 books and nearly 20,000 baby items. In total, over 87,000 gifts of appreciation have been distributed. M.C.C. has no paid staff members, it is an all-volunteer organization. Military children across multiple branches of the U.S. Armed Forces were repeatedly reminded that Americans care about their sacrifices for their parent(s) to serve our nation. MCC received multiple awards and recognitions from the military this year for our support acknowledging their military children.
